# IMPORTANT INSTRUCTIONS FOR PARENTS

- **1.** Review the checklists at the top of the application to determine which documents are required for your child's application.
- **2.** All forms must be **printed in color**: **red text must print in red**. All forms must be filled completely.
- **3. Both legal guardians/parents are required** wherever parents' signatures are indicated, and circle their relationship to the child, regardless of with whom the child resides with.
- **4.** If sole custody, he/she must check "yes" and initial where indicated on the Parent/Guardian Release and Waiver of Liability and on the Statement of Health. A copy of the court order indicating sole custody is required as well.
- **5.** Two documents must be notarized. See additional instructions below.
- **6.** A separate packet must be submitted for each child who participates. Photocopies, faxes, and/or scans are not accepted.
- **7.** Fees are due at time of application: See Section 6 of application.
- **8.** Submit this packet with any additional required documentation to your home Division Office for processing.

# LICENSE RUN REQUIREMENTS

# Before beginning license runs:

Sections 1, 5, 6 and 7 of the Application for NHRA Jr Street Competition License must be completed, **including notarization of the waiver in section 7**. For specifics on license runs and other testing, see sections 2 and 3 of the Application.

# Two documents must be notarized:

- 1) Jr Street Competition License Application, Section 7
- **2)** Parent/Guardian Release and Waiver of Liability.

# NHRA JR STREET COMPETITION LICENSE REGULATIONS

The license issued by NHRA is to be used only by the driver to whom it is assigned, and it is restricted to the categories listed on the license. The license is valid until its expiration date or until suspended or revoked by NHRA. The license is intended only to signify that the driver has demonstrated basic qualifications for drag racing classes up to and including the one in which the driver has qualified. The license does not convey a right but rather conveys a revocable privilege to participate in events.

# **GENERAL**

- 1) All license applicants must be a minimum of 13 years of age and may participate through the year of their 16th birthday.
- 2) Both legal parents must sign and date the Application/Minor Release and Waiver and circle their relationship to the child where indicated, regardless of with whom the child resides. If one person has sole custody, he/she must check "Yes" where indicated on both the Application/Minor Release and Waiver. In cases of sole custody or guardianship, copy of the court order must be included in addition to signature and relationship.
- 3) Drivers must be in possession of temporary or permanent NHRA License Certificate and NHRA Membership to be eligible for competition.
- 4) If any test runs are older than one year, all runs must be re-run and completed at an NHRA Member Track.

# **NEW DRIVER REQUIREMENTS**

- 1) The applicant will inform the track manager and/or duly authorized track official of intent prior to any passes. Signatures of observers and times must be filled in after each run.
- 2) The following tests are required:
  - a. A vehicle orientation test conducted by a track official.
  - b. A basic driving test conducted by a track official.
  - c. The track official will make one run as a passenger with the participant to determine vehicle safety and eligibility.
  - d. Track official orients applicant with track fixtures.
  - e. Applicant will complete passes 1-6; a minimum of 5 passes with the assigned supervising adult and a minimum of 1 pass with the track official. Six passes will need to be approved and signed by both the supervising adult and track official.
  - f. Official will deny a license to any participant s/he feels cannot handle the vehicle.
- 3) After passing the driver tests, the applicant will complete the license application form in full then mail it along with the original time slips, certified birth certificate, and notarized minor waiver & release to National Field Office, 140 Via Verde, Suite 100, San Dimas, CA 91773.

# ADDITIONAL VEHICLE REQUIREMENTS

- 1) The applicant will inform the track manager and/or duly authorized track official of intent prior to any passes. Signatures of observers and times must be filled in after each run.
- 2) The following tests are required:
  - a. A vehicle orientation test conducted by a track official.
  - b. A basic driving test conducted by a track official.
  - c. The track official will make one run as a passenger with the participant to determine vehicle safety and eligibility.
  - d. Track official orients applicant with track fixtures.
  - e. Applicant will complete passes 1-3; a minimum of 2 passes with the assigned supervising adult, and a minimum of 1 pass with the track official. All passes will need to be approved and signed by the supervising adult and track official.
  - f. Official will deny a license to any participant s/he feels cannot handle the vehicle.
- 3) After passing the driver test, the applicant will complete the license application form in full then mail it along with the original time slips to National Field Office, 140 Via Verde, Suite 100, San Dimas, CA 91773.

# NHRA LICENSE RENEWAL REQUIREMENTS

- 1) A completed application & waiver will be required to renew the Jr Street license for all registered competitors.
- 2) Complete the license application sections 1, 5, 6, 7, 8 in full then mail it along and notarized minor waiver & release to NHRA Division Office.

# THIS AGREEMENT SHALL APPLY TO ANY AND ALL NHRA AND NHRA MEMBER TRACK EVENTS OR ACTIVITIES ("EVENTS")

# PARENT/GUARDIAN RELEASE AND WAIVER OF LIABILITY ASSUMPTION OF RISK AND INDEMNITY AGREEMENT FOR PERSONS UNDER AGE 18 - THIS AGREEMENT MUST BE NOTARIZED

IN CONSIDERATION of ALLOWING MY BELOW-NAMED MINOR CHILD ("the minor") to compete, officiate, observe, work for, or participate in any way in the EVENT(S) or being permitted to enter for any purpose any RESTRICTED AREA (defined as the advanced staging area, burn out area, competition area, shutdown area, staging lanes, return road area, and any other area within the barriers, fences, and/or structures separating the general public from racing activities), I, THE UNDERSIGNED, on behalf of the minor child, for myself individually and for my children, wards, personal representatives, heirs, and next of kin:

- 1. Represent and agree that I know the nature of the EVENT(S) and the minor's experience and capabilities, and I affirm that the minor is fit and qualified to participate in the EVENT(S).
- 2. Agree and represent that I and the minor have or will immediately upon entering any such RESTRICTED AREAS, and will continuously thereafter, inspect the RESTRICTED AREAS and further agree and warrant that, if at any time, we are in or about RESTRICTED AREAS and believe anything of any nature to be unsafe or unsatisfactory in any way, we will immediately advise the officials of such and will leave the RESTRICTED AREAS and/or refuse to participate further in the EVENT(S).
- 3. HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the promoters, participants, racing associations, sanctioning organizations or any affiliated entities thereof, track operators, track owners, officials, vehicle owners, builders and designers, drivers, crews, rescue personnel, and persons in any RESTRICTED AREA, promoters, sponsors, equipment and parts manufacturers and suppliers, advertisers, owners and lessees of premises used to conduct the EVENT(S), premises and event inspectors, surveyors, underwriters/brokers, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities, regarding the premises or EVENT(S) and for each of them, their directors, officers, agents, and employees, (the "RELEASEES") FROM ALL LIABILITY TO ME, to the minor, and to my children, wards, personal representatives, assigns, heirs, and next of kin, FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMAND THEREFORE ON ACCOUNT OF INJURY TO PERSON OR PROPERTY OR RESULTING IN DEATH ARISING OUT OF OR RELATED TO THE EVENT(S), WHETHER CAUSED BY NEGLIGENCE OF ANY RELEASE(S) OR OTHERWISE.

HEREBY AGREE that if, despite signing this Agreement, I, the minor, or anyone on the minor's behalf, makes a claim for loss or damage against any of the Releasees, I AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS the RELEASEES and each of them FROM ANY LOSS, LIABILITY, DAMAGE, FEES OR COSTS they may incur arising out of or related IN ANY MANNER TO MY OR THE MINOR'S ATTENDANCE AT OR PARTICIPATION IN THE EVENT(S), AND WHETHER CAUSED BY THE NEGLIGENCE OF ANY RELEASEE(S) OR OTHERWISE.

# NHRA COMPETITION LICENSE REGULATIONS

The license issued by NHRA is to be used only by the driver to whom it is assigned and it is restricted to the categories listed on the license. The license is valid until its expiration date or until revoked by NHRA. The license is intended only to signify that the driver has demonstrated basic qualifications for drag racing classes up to and including the one in which the driver has qualified.

The license does not convey a right but rather conveys a revocable privilege to participate in events.

# **GENERAL**

- 1) All drivers competing in NHRA License Level 1, 2, 3, 4, 6 and certain Stk, SS, SST classes as defined by current NHRA rules, with a dial-in of 9.99 or quicker (4.50-6.39 for eighth-mile) or 135 mph or faster (mph excludes motorcycle) are required to have a valid NHRA Competition License and NHRA Membership.
- 2) The minimum age for any professional category applicant is 18 years of age.
- 3) All NHRA Level 1-3 licensed drivers are required to pass an NHRA physical examination every two (2) years. TF and FC require an annual physical. Any matter in this examination, including without limitation any condition or medication may be referred to an NHRA medical consultant for review, and may be cause for rejection.
- 4) Drivers must be in possession of temporary or permanent NHRA License Certificate and NHRA Membership to be eligible for competition in any category that requires an NHRA Competition License.
- 5) NHRA Level 1-3 Competition License & Numbers are issued as a unit and are valid for two years from the date of physical examination; TF or FC are valid for only one year. NHRA Level 4-7 Competition License & Numbers are issued as a unit and are valid for one or two years from the end of the month of processing.
- 6) NHRA Level 5 & 7 license applicants not holding a state or government issued driver's license beyond a learner's permit, will be required to complete license runs 1 thru
- 7) NHRA Level 4-7 license runs may be completed at an eighth-mile track. For a Level 2 or 3 license, runs 1, 2, 3 & 4 can be completed at an eighth-mile track, but runs 5 & 6 must be completed at a quarter-mile track for an unrestricted license. If full runs 5 & 6 are completed on eighth-mile, license will be issued with eighth-mile only restriction.
- 8) Level upgrade from 5 or 7 to a Level 1, 2, or 3; must complete "New Driver Requirements". If applicant upgrading from Level 5 or 7 to Level 4 or 6; track official may waive runs 1-3 if continuing competition in same vehicle.
- 9) Drivers who have not competed or have let their NHRA license expire for a period of two (2) years will have to meet all NEW DRIVER REQUIREMENTS. For professional drivers who have not competed for two years, license will become inactive, three (3) license runs will be required to re-activate; see runs 4, 5 and 6. All license runs must be completed at an NHRA Member Track.
- 10) If any license runs are older than one year, runs 4, 5 and 6 must be re-done and completed at an NHRA Member Track.
- 11) In accordance with the Applicant's Affirmation and Agreement on the front of this document, all drivers are subject to NHRA's rules and regulations in connection with their participation in any NHRA or NHRA member track event. I know the NHRA Rulebook, including amendments, is available to me online.
